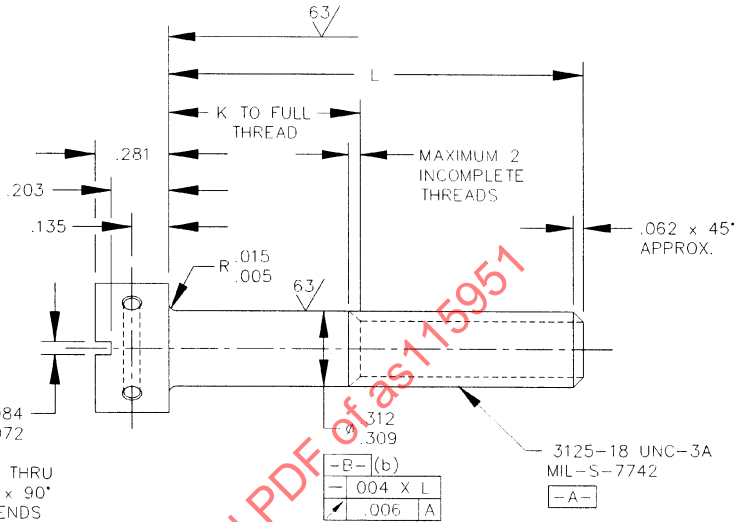
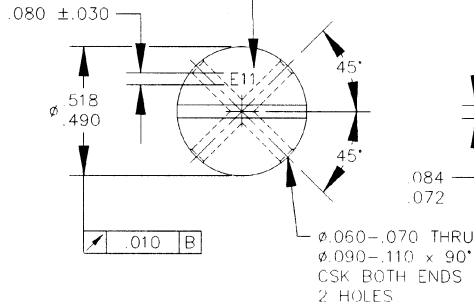


OPTIONAL METHOD OF SLOTTING
